MEETING MINUTES

A quorum was established and the Call to Order was at 7:00pm by Moderator, Neil Butler. Rev. Lisa Bowersock offered an opening prayer.

Minutes: Diane van Deusen

Minutes to the February 2025 meeting were made available prior to the meeting for Council members to review. A Motion to approve the Minutes was made by D. Zuber and seconded by C. Rose. The vote was affirmative.

Rev. Bowersock led us in the Lord's prayer to conclude the meeting.

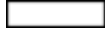
Motion to Adjourn made by D. Zuber, seconded by C. Rose.
